

Single-User Licence

Definitions

“User licence” means the licence issued to the Licensee confirming the terms of use granted to the Licensee by MEPS.

“Licensor” or **“MEPS”** or **“We”** means MEPS International Ltd, 263 Glossop Road, Sheffield S10 2GZ, United Kingdom.

“Licensee” or **“Company”** means the person, company or organisation named as the licensed Company and who is granted permission to use MEPS data as per the terms herein.

“MEPS data/data/material” means any information provided by MEPS within its publications, data-tables, or any other service.

“Data-tables” means all data published through MEPS portal account, which includes, price data, production data, indices, and forecasts.

“Publications” means MEPS Monthly Steel Reviews and MEPS Outlooks, which are delivered to the Licensee monthly, quarterly, or annually via email.

“Other services” means any service, excluding publications and data-tables, but including, any bespoke one-off product that is produced by MEPS for the Licensee.

“MEPS portal account” means the MEPS website or website area accessible by the Licensee. Only MEPS online products are available via the MEPS portal.

“Subscription” means the supply by MEPS of MEPS publications/data-tables over a set period of time as stated on your MEPS portal account/invoice.

“Named Authorised User” or **“You”** means the named employee of the Licensee who has been identified by the Licensee to be the recipient of the publications or data-tables.

“Single user” means the allocation of a single-user licence granting one user the right to receive and use MEPS publications or data-tables, including any other copyright material MEPS may provide to the Licensee.

“Intellectual Property Rights or IP Rights” means all patents, copyrights, design rights, trademarks, service marks, trade secrets, know-how and any other intellectual property rights (whether registered or unregistered) and all applications for the same, anywhere in the world.

Precedence

For the protection of MEPS copyright material this licence agreement is the entire agreement between the Licensee and Licensors and supersedes all other agreements, proposals, terms or representations, written or oral.

The Licensee accepts the Licensors' terms and conditions herein. For avoidance of doubt, and for the protection of MEPS copyright, both parties proceed in the knowledge that upon payment of the invoice and/or receipt of MEPS data, the terms and conditions herein will prevail and take precedence over all other terms and conditions, whether signed by the Licensee or not.

If the Licensee is unable to accept the Licensors' terms, the Licensee must state this as soon as the Licensee is in receipt of MEPS invoice, or data. If the Licensors are unable to accept the terms herein, the Licensors must delete all copies, in whatever format, of MEPS data and confirm to the Licensee in writing within seven days of notification of non-acceptance that all MEPS data has been destroyed or removed from their systems. The Licensors will cancel the subscription with immediate effect.

Licence Details

This document grants the Licensee a single-user licence to the products and subscription period detailed above under products purchased.

The supplier grants the Licensee a single-user, non-exclusive, revocable, non-transferable, limited licence to access and use MEPS data. The use of MEPS reports/data is restricted to ONE Named Authorised User on behalf of the Company. The Named Authorised User will be the named recipient of MEPS data/reports.

The company is responsible for ensuring compliance, at all times, with the terms and conditions of the licence terms herein, ensuring the Named Authorised User is aware and understands the terms herein. The Company may change the Named Authorised User by contacting MEPS Customer Service team in writing.

The company may not assign, sub-licence, transfer or otherwise dispose of any of your right or obligations under this licence without prior written consent from MEPS. Under no circumstances is MEPS data to be made available on any INTERNET or INTRANET or any other device or site where access is made available to persons not directly employed by the company or who are not authorised to use MEPS data under the terms of this licence.

Should the Licensors allow the Licensee access to MEPS data prior to this agreement being signed or invoice being paid, the Licensee shall use MEPS data in accordance with the licence terms herein.

Scope and Limitations

This licence is restricted to one Named Authorised User. Under these terms you are not allowed to forward, email, transmit, display, or reproduce and distribute MEPS data by any means to persons not authorised under this licence.

You are not allowed to store, save, or display MEPS data, or allow anyone other than the Named Authorised User access to MEPS data.

Unless for the sole use of the Named Authorised User you may not, translate, reverse engineer, decompile, disassemble, modify, or create derivative works/cost models based on MEPS data. Derivative works, cost models, reversed engineered or translated documents can not be shared, forwarded, emailed, transmitted, displayed, reproduced or distributed without the written permission from the Licensee. Material produced containing MEPS data that is then shared with any persons unauthorised under this licence will be a material breach of the licence terms.

Ownership

MEPS retains ownership of the MEPS material and all subsequent copies of the MEPS material made available to you and all IP Rights in or relating to the MEPS material, regardless of the form in which the copies may exist. This licence is not a sale of the original MEPS material or any copies of it.

Should any copyright infringement occur or there be any breach of the terms of this licence, immediate action must be taken by the Licensee to stop the infringement or breach and a member of MEPS team must be notified. Failure to notify MEPS of such an infringement or breach will result in your licence being terminated with no refund. Should the user or the Company require use of MEPS data over and above that stated within this licence, the Licensee must obtain permission in writing from MEPS.

Use of AI with MEPS Intellectual Property

Permitted Use of MEPS Data in AI Systems

1.1 The Licensee is only permitted to input MEPS copyright-protected data into private AI systems that are exclusively trained on and deployed for internal use within their organisation. Any such AI system must operate within a secure, private environment that ensures MEPS data remains confidential and protected from unauthorised access.

1.2 The Licensee may integrate MEPS data into private Large Language Models (LLMs) or AI systems solely for the purposes of training, refining, or conducting real-time AI queries tailored to their organisation's needs and not for any other purpose.

Prohibited Use of MEPS Data in General AI Systems

2.1 Licensee is expressly prohibited from inputting, uploading, or otherwise sharing MEPS copyright data with any general-purpose, publicly accessible AI models, including but not limited to OpenAI's GPT, Google Gemini, Microsoft Copilot, or other similar platforms.

2.2 The Licensee shall ensure that any AI integration involving MEPS data is restricted to systems under their direct control and not exposed to external AI services or platforms that may retain, reuse, or otherwise process such data beyond the Licensee's internal operations.

Compliance and Breach of Terms

3.1 The Licensee agrees to implement appropriate safeguards to prevent unauthorised use of MEPS data in AI systems and to comply with all applicable intellectual property laws and confidentiality obligations.

3.2 Any breach of these terms may result in the immediate termination of access to MEPS data and potential legal action.

Liability for Breach

4.1 In the event of any unauthorised use of MEPS data in general AI systems, the Licensee shall be liable for any resulting damages, including but not limited to financial penalties, legal costs, and any remedial actions necessary to mitigate potential misuse and shall indemnify MEPS against all liabilities, damages and losses (including loss of profit, loss of business, loss of reputation, loss of savings and loss of opportunity), fines, expenses and costs (including all interest, penalties, legal costs (calculated on a full indemnity basis) and reasonable professional costs and expenses) suffered or incurred by MEPS as a result of or in connection with any breach of this clause by the Licensee.

Cancellations/Refund Policy

Subscriptions to publications, data tables, or forecasts can only be cancelled at the end of the subscription term. No refund will be issued for early cancellation.

MEPS may terminate your Company Licence at any time on the basis that it will repay you a proportion of the licence fee for the remaining period of the licence, except where the Licensee has breached the terms of the Company Licence granted by MEPS to the Licensee.

Expiry of this Agreement

The Company Licence shall automatically terminate at the end of the current subscription term as detailed within these terms and conditions.

Copyright restrictions and MEPS ownership of material is permanent and therefore remains active after the subscription has expired and while ever the Licensee is in possession of such copyright protected material.

No Warranty

MEPS data is obtained and compiled from sources in the steel market which MEPS considers to be reliable and accurate. MEPS uses reasonable endeavours to ensure that the information obtained is correct and that its analysis is reliable, but no warranty is made as to the accuracy of the data.

Accordingly, MEPS does not give any warranties in respect of the services or information provided, except we hereby warrant that we are the owner of such intellectual property rights as may subsist in the information, to the extent that it comprises a database, as such term is defined in the Copyright, Designs and Patents Act 1988.

The data is provided on an “as is” basis without guarantee of accuracy or completeness. MEPS does not:

- Give any warranty that the services it provides and the access to the data will be error free or uninterrupted.
- Guarantee the availability or timeliness of the service or information.

Save to the extent set out in the agreement, all implied warranties or conditions of satisfactory quality, merchantability, and fitness for a particular purpose are excluded to the fullest extent permitted by law.

You assume the entire risk as to the use and performance of the material provided.

We will use reasonable skill and care in the provision of the other services.

Limitation of Liability

If, during the subscription period, you are unable to access material via MEPS website for an extended period, MEPS will send you an electronic version of the material.

Advertised publication and updating dates are intended as a guide only and under no circumstances constitute a guarantee, warranty, or condition of the contract. If MEPS fails to publish and/or to deliver any material at all or in the event of any other failure, technical or otherwise, to publish or update individual publications/data tables in a timely manner, MEPS' liability will be limited to providing a full or partial refund for any monies paid.

In no event will MEPS be liable to you for any damages for any lost profits, loss of business, lost contracts, lost savings, loss of data, or any indirect, special incidental, or consequential damages arising out of any breach of contract or warranty, tort (including negligence and strict liability), of the use of or inability to use such materials, even if MEPS has been advised of the possibility of such damages. GDPR

For the purposes of this clause, “Personal Data” refers to any personal data, including for example, employee names, individuals or Company address, email addresses, and Company or mobile telephone numbers relating to this agreement, which is processed by either party in connection with this Agreement.

The parties acknowledge that for the purposes of this agreement they will be separate and independent controllers with respect to any processing of personal data. In carrying out such processing, each party shall comply with the obligations applicable to it under the data protection laws, including without limitation:

- Ensuring that it has identified appropriate legal bases for its processing.
- Providing appropriate information to data subjects about the processing of their personal data that complies with the requirements of the data protection laws.
- Taking all measures required pursuant to GDPR and UK GDPR to ensure the security of processing of the personal data.
- Each party shall only process the personal data received from the other party for the purposes of performing this agreement.

- If either party becomes aware of a personal data breach affecting the personal data, it shall notify the other party without undue delay and provide such information and assistance as the other party may reasonably require.
- Each party shall provide reasonable assistance as may be requested by the other party in connection with the requesting party's obligation to: i) respond to any data subject rights laid down in the GDPR and UK GDPR; and ii) comply with any assessment, enquiry, notice, or investigation under any data protection laws in respect of the personal data or this clause.

The terms "Controller", "Processor", "Data Subject", "Personal Data", "Personal Data Breach" and "Process/Processing" shall have the same meaning as described in the Data Protection Laws.

"Data Protection Laws" means the General Data Protection Regulation 2016/679 of the European Parliament and of the Council ("GDPR") as transposed into United Kingdom national law by operation of section 3 of the European Union (Withdrawal) Act 2018 and as amended by the Data Protection, Privacy and Electronic Communications (Amendments etc.) (EU Exit) Regulations 2019 ("UK GDPR"), together with the Data Protection Act 2018, the Data Protection, Privacy and Electronic Communications (Amendments etc.) (EU Exit) Regulations 2019 and other data protection or privacy legislation in force from time to time in the United Kingdom or, and to the extent applicable, the data protection or privacy laws of any other country.

Force Majeure

MEPS will have no liability for any delay or failure to perform any of its obligations hereunder if the delay or failure is due to causes outside of its reasonable control.

General

The Licensee agrees that MEPS shall have the right, after supplying material, to use whatever means at MEPS' disposal, to audit and track compliance with the Licensee's Company Licence.

Amendments

No amendment to the agreement shall be valid and binding unless it is in writing and signed by both parties to it.

Laws

The terms and conditions and Company Licence are governed by and construed and interpreted in accordance with the laws of England and Wales, and the English courts shall have exclusive jurisdiction in any dispute.

Use of MEPS Copyright Material

You MAY:

- Have direct access to MEPS reports as a named authorised user. Named authorised users are allowed to use MEPS data as part of their duties within the Licensed company.
- Occasionally (once per quarter) extract and send, or verbally quote **small** sections of MEPS data to persons who are not authorised under this licence. A small extract is classified as no more than 1 to 2 products with no more than 3 months data, sent no more frequently than quarterly. Extracts of data are restricted to one company and not per person. **Extracts of data MUST NOT be shared with the same company/person any more frequently than twice a year.** All extracts of MEPS data must be sourced to MEPS.

© All rights reserved: MEPS data is licensed for the exclusive use of the Company's direct employees. Any unauthorised copying, forwarding, or sharing by any means will be an infringement of copyright.

Regular and frequent sharing of MEPS data will be a material breach of your licence terms. Any persons requiring a copy of MEPS material for their own use must purchase a licence directly with MEPS.

You **MUST NOT**:

- Share MEPS data, create shared access, or allow any other persons the use of your MEPS data if they are not authorised under this licence. This includes employees who are not licensed to receive and use MEPS data, consultants, customers, suppliers, parties, or persons not directly employed by the company, friends, or any other persons not authorised under this licence.

- Failure to comply with MEPS licence terms will constitute a breach of MEPS copyright and will result in your licence being terminated with no refund and possible legal action.
